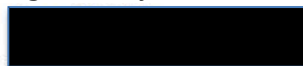

You are hereby placed on full lawful and moral notice.

I, Nga Thi Tuyet Tran, operating in My full Divine Capacity as a Delegation of Universal Law

2. A concise evidentiary summary, detailing criminal conduct, systemic corruption, and administrative misconduct enacted against Myself and My Children - all of which remain unremedied,

3. This present covering declaration, issued in full Truth and with all authority endowed by Prime Creator, to serve as an eternal record of notice and opportunity for Your Nation to now respond in good faith.

This matter is not private. It is of global and eternal relevance. The crimes inflicted upon My Family by agents of the Austrian State are not isolated acts - they are emblematic of a collapsing governance model built upon deception, coercion, and the suppression of Divine Rights.

As of the issuance of this notice, Your Nation is bound by knowledge. Silence, inaction, or complicity will be recorded as agreement with the criminal enterprise of Austria's institutions. Equally, any good faith action taken by Your Nation - such as lawful observation, inquiry, or diplomatic engagement - will be recorded as alignment with Truth and Remedy.

The lawful process of restoration has already begun. It is named the Divine Global People's Monetary System (Divine GPMS.world) - a complete and righteous replacement for all corrupt systems. Your Nation is invited to witness, participate, or support the transition - or to remain recorded on the wrong side of history.
