OPEN LETTER & PUBLIC NOTICE

To All Those Holding Office Within the Austrian District Leadership

(Unnumbered and unsigned by request, that each may know within themselves if this is addressed to them.)

In the name of God, Prime Creator, and on behalf of the Global People who stand in Truth and Peace, this Open Letter is issued as both a lawful notice and a moral invocation.

You are hereby notified that lawful liens of €1 trillion and €1.5 trillion have been placed upon the Republic of Austria and its commercial insurance structure, in direct response to verified, documented, and incontestable violations against innocent individuals, families, and the broader collective of humanity. These liens were issued in accordance with the unalienable Right of all Sovereign People to seek Remedy and enforce Divine and Natural Law when harm is done and ignored by those in office.

This letter now places the matter openly before You—the local leaders and administrators who are bound not only by the Austrian Constitution and applicable administrative codes, but by a higher duty to Truth, transparency, and the welfare of the People You serve.

We invoke and present the following undeniable principles and obligations:

1. Austrian Legal Duty of Disclosure

As public officials, You are under legal and fiduciary obligation to inform Your constituents of material developments affecting the public good, public funds, and national integrity. These liens are lawfully served, internationally observed, and carry enforceable weight. Failure to disclose them to the public violates principles of good governance, transparency, and lawful accountability.

2. Incontestable Public Right to Know

This Notice is being publicly disseminated so that the People—whom You are sworn to serve—may become aware of the existence and substance of these lawful liens, and the reasons they have been placed. Every Austrian resident and family has the Right to full disclosure, especially when such remedies offer a clear path toward correction, healing, and justice.

3. Moral Duty to Acknowledge and Respond

While silence may seem convenient or protective in the face of lawful challenge, it constitutes moral cowardice. Each district official is now given the opportunity to choose integrity: to acknowledge the presence of these liens and to act with courage and conscience by informing the People.

4. Obligation to Clarify Measures Taken

You are hereby requested to publicly state whether any action has been taken within Your district to:

- Acknowledge the existence of the liens,
- Investigate or evaluate their lawful standing,
- Communicate them to higher offices of government,
- Remedy or initiate remedy for the wrongs identified,
- Or to otherwise respond to the lawful claims therein.

5. Divine and Peaceful Remedy is Offered, Not War

This Public Notice is not a threat, nor a declaration of hostility. It is a sacred gesture of Remedy, extended to all who still hold position within the collapsing structures of the old world. You are being given the opportunity to align with Truth, to honor your moral responsibility, and to walk the path of transparency before the eyes of your People and the eyes of God.

This Open Letter and Notice stands as a lawful and public record, and its delivery, either digitally or in person, serves as constructive notice to all recipients and observers.

These firms now carry constructive notice and are invited to engage professionally with the claims herein, for the sake of justice and national truth.

Footnote – On Silence and Accountability:

"Let it be known: Silence is now Consent to Accountability." This phrase means that when district leaders receive lawful public notice and choose not to respond, that silence is interpreted as agreement by default—both lawfully and morally. In law, this is known as tacit acquiescence, where failure to answer a claim means one has no lawful objection. Morally, silence in the face of injustice equals complicity. Spiritually, such silence creates energetic and karmic accountability, recorded by one's own Higher Self and the Divine. In this context, silence is not protection—it becomes a living admission of responsibility.
