THE EURADOPT NETWORK IS UNSAFE

Immediate Suspension of Austria and Steps to Dismantle a Captured System

Issued by the People's Mandate — Divine-GPMS.world — For Immediate Circulation

Core Statement

The child-protection and intercountry-adoption web linking EurAdopt member agencies to each State's child-services Central Authority (Hague 1993 framework) is structurally compromised. Austria's conduct in Sister Nga Thi Tuyet Tran's case is a clear, present danger to Children. Where one State's child-services are captured, the whole EurAdopt network becomes unsafe, because accreditation, paperwork, and statistics are controlled inside the same loop.

What the public must understand

Children are disappearing inside State custody; incident volumes in Europe are anomalously high, and disappearances from Austrian federal reception occur at the very start of the process.

The governance mesh creates an Intentional Blind Spot: the bodies that license and certify also keep the books—and refuse to investigate when the record itself is the crime.

After China ended intercountry adoptions (2024), demand did not vanish; it redirected. Vietnamese children—like Aurora (girl) and Akua (boy)—sit precisely where market bias and supervisory failure meet.

This is not "a few bad cases." It is a system that converts Children into inventory and exhausts Families through paperwork, delays, and silence.

Determination

Because EurAdopt agencies operate only through State child-services authorities, proven capture in one State infects the network. The proportionate response is structural: suspend the unsafe node now, pause cooperation across members, and dismantle EurAdopt's operational role if capture proves systemic.

Immediate Demands (effective today)

Suspend Austria from EurAdopt pending safeguards; call an extraordinary EurAdopt meeting to censure/suspend Austrian member(s).

Article 33 actions (Hague 1993): other Central Authorities must file formal risk notices to Austria, publish those letters, pause cooperation, and refuse recognition where Child-protection requires.

Open the files: independent monitors to audit intake/exit ledgers at federal reception, agency case files, and vendor/payment lists; protect whistleblowers.

Expose shadow finance: publish fee schedules and ledgers (agencies and partner NGOs), full vendor lists with beneficial owners; ban "donations" tied to placements; escrow any legitimate costs.

Family-first relief: fast-track reunification reviews and support for affected Families; secure hotlines and safe channels for Children and witnesses.

People's Mandate (Divine-GPMS.world)

We, the People, declare that Children are not commodities. We demand suspension, transparency, and restoration now. The remedy must end the profit logic, restore Family sovereignty, and replace the captured apparatus with humane, transparent systems guided by Divine Law and the Universal People's will.
