Ms. Nga Thi Tuyet Tran, Berg im Drautal, filed a complaint against the District Authority Spittal an der Drau with the Ombudsman's Office. She stated that Child and Youth Services are not acting objectively and are favoring the father. She was at the authority for the first time on 26 June 2024 and reported that the father was regularly under the influence of alcohol during contacts with the children and also consumed alcohol while driving. Furthermore, he exercised psychological violence against the daughter. Both children were therefore afraid of him and wanted contact rights to be suspended until further notice. After visits, the children had nightmares and were already showing behavioral abnormalities. Nevertheless, the District Authority demanded that she continue to hand over the children to the father on visitation days.

At the beginning of August, an incident occurred at the Kirtag in Villach. The father shouted at the four-year-old daughter, pulled her by the hand, and let her fall to the ground. Bystanders called the police. He was also under the influence of alcohol at that time.

According to the report of LSE Kärnten under file number PAD/25/01425627/001/KRIM, the letter of Nga Thi Tuyet Tran dated 01.06.2025, which was addressed to MMag. Markus Lerch (BH Spittal/Drau), was forwarded. Reference is also made to the previous case 10 St 70/25b. In this respect, at least internal inquiries were carried out.

The letter of 01.06.2025 contains a **payment demand (financial compensation)** in the amount of **EUR 74,000.00**. The suspect (Nga) stated that due to the actions of the named persons (in connection with the unlawful removal of her children), she incurred costs.

The criminal provision of § 247a StGB requires a **hostile movement** (a group of many people) that aims to fundamentally reject the sovereignty rights of the Republic and to assume such sovereignty rights for itself. Accordingly, there must be a long-term, repeated, complete rejection of sovereignty rights.

In this case, there is neither suspicion of the accused belonging to such a group, nor that such a group is oriented toward the required aims. Therefore, the proceedings were terminated pursuant to the legal and factual considerations of § 190 StPO.

2. This action was **unlawful**, a **breach of human rights**, and an act of **child abduction** under both national and international law.
3. The **so-called authorities** acted without jurisdiction, without presenting valid documents, and without the required contracts or evidence.
4. I, as the **biological mother**, retain **full custody and natural rights** over my children.
5. The removal of my children was carried out under **deception, fraud, and hearsay**, and therefore is **null and void**.
6. No evidence, no trial, and no valid order existed at the time of removal; this makes the act a **gross miscarriage of justice**.
7. These actions constitute violations under:
